Know All Men by These Presents:

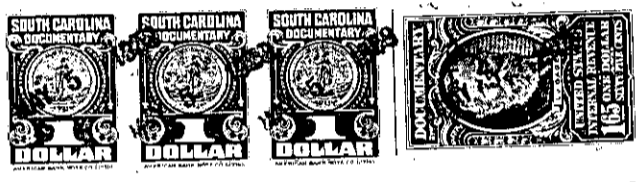
That I, ZET SMITH, in the State aforesaid, in consideration of the sum of ONE THOUSAND SEVENTY-EIGHT & 15/100 (\$1,078.15) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HAZEL RUCKER, HER HEIRS AND ASSIGNS FOREVER,

ALL that certain piece, parcel or lot of land in Gantt Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 14 on the plat of the property of Zet Smith, said subdivision being known as "Smith Heights"; said plat being made by C. O. Riddle, Surveyor, April, 1953, and recorded in the R.M.C. Office for Greenville County in Plat Book "BB", at page 147, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING AT AN IRON PIN ON THE southwestern side of Zet Court, joint front corner of Lots Nos. 13 and 14, and running thence with the common line of said Lots, S. 39-49 E., 106.9 feet to an iron pin on said line, joint rear corner of Lots Nos. 14 and 15; thence with the common line of Lots Nos. 14 and 15, S. 50-11 W., 159.8 feet to an iron pin on the Southeastern side of Zet Court, joint front corner of Lots Nos. 14 and 15; thence running with the Southeastern side of Zet Court, N. 24-26 W., 63 feet to an iron pin; thence continuing with the Southeastern side of Zet Court, N. 7-32 E., 50 feet to an iron pin; thence continuing N. 35-58 E., 50 feet to an iron pin; thence continuing N. 50-11 E., 58 feet to the beginning corner.

This lot is conveyed subject to the twenty-five (25) foot building line as shown on the above referred to plat.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
