to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Ray M. Blakely, his heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 9 of Indian Hills, plat of which is recorded in plat book QQ at page 11, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Chickasaw Drive at the joint front corner of Lots Nos. 8 and 9, and running thence with Chickasaw Drive, N. 59-30 E., 70 feet to an iron pin at the intersection of Chickasaw Drive with Hiwassee Drive; thence with the curve of said intersection, the chord of which is S. 75-30 E., 56.6 feet to an iron pin; thence with Hiwassee Drive, S. 30-30 E., 135 feet to an iron pin; thence S. 59-30, W., 110 feet; thence N. 30-30 W., 175 feet to the point of beginning.
