

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina, about three miles southwest from City of Greer. Bounded on the north by Roscoe Green Estate; East by Floride Johnson; South by F S Nix and West, now or formerly, by Mrs. Greer, andbeing the same conveyed to me by deed of Floride Johnson, recorded in Vol.472 at page 283, and described is follows:
