An undivided one-half interest in and to the following described property: .

Parcel No. 1: All that certain piece, parcel or lot of land, in Bates Township, County of Greenville, in the Town of Travelers Rest, lying and being on the easterly side of Geer Highway, and having according to a plat entitled "Property of Fannie E. Goodlett Estate", made by W. J. Riddle, November 9, 1939, revised February, 1946, the following metes and bounds, to-wit:
