



BEGINNING at an iron pin on the center line of Parkins Mill Road at intersection with Cleveland Street Extension; thence S. 62-20 W. 72.7 feet to an iron pin on the center line of Parkins Mill Road; thence S. 18-26 W. 72.3 feet to an iron pin on the Eastern side of Parkins Mill Road; thence along the Eastern side of Parkins Lake Road, S. 25-27 E. 700 feet across a branch to iron pin; thence N. 39-34 E. 158 feet to an iron pin; thence N. 65-30 E. 110.3 feet to an iron pin; thence N. 80-37 E. 157.4 feet to an iron pin; thence N. 69-43 E. 111.4 feet to iron pin; thence S. 79-19 E. 77.2 feet to iron pin; thence N. 76-36 E. 93.1 feet to iron pin, rear corner tracts 2 and 4; thence N. 34-45 W. 818 feet to iron pin on center line of Parkins Mill Road; thence along the center line of said road, S. 64-35 W. 410 feet to the beginning.

Being the same property conveyed to Grantor by deed recorded in Deed Book 493 at page 249.

ALSO: All that certain piece, parcel or strip of land adjoining the above described tract on the eastern side and having the following metes and bounds:
