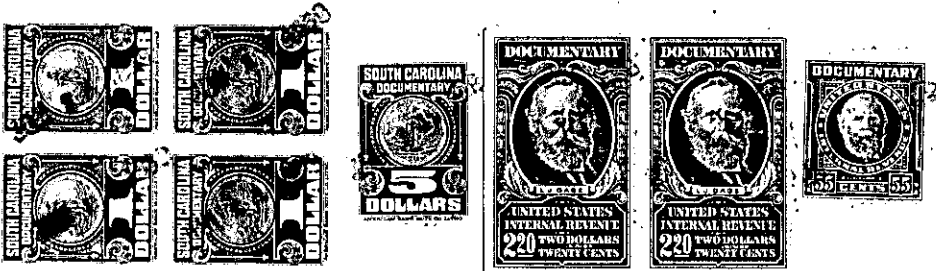
Know All Men by these Presents:

T. MEDLIN, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the north side of the Farr's Bridge Road, containing 0.79 of an acre, more or less, and described as follows:

BEGINNING at an iron pin in the western boundary of the Groce Road, 482 feet North of the southern boundary of Farr's Bridge Road, and running thence N. 27-51 W. 332.5 feet to a point in the southern boundary of the Groce Road; thence along the Southern and Western boundary of said road as follows: S. 86-17 E. 90.9 feet; thence S. 46-13 E. 59.7 feet; thence S. 19-10 E. 65.5 feet; thence S. 0-13 E. 186.5 feet to the beginning corner. These courses and distances are shown on a plat of the Nannie McRabb Lands made by D.E. Woodward and J. MacRichardson in September 1951.
