to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), has (have) granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William Henry Hudson and Jane Reed Hudson
All those certain pieces, parcals, lots or tracts of land lying, situate and being on the southeast side of River Drive, at River Falls, Cleveland Township, Greenville County, S.C., being shown as lots 8 and 9 on plat of Cool River Heights made by J. C. Hill, Surveyor, September 2, 1947, recorded in R.M.C. Office for Greenville County, S. C. in Flat Book "S" at Page 5, and having, according to said plat, the following metes and bounds, to-wit:
Lot No. 1: BEGINNING at an iron pin in center of River Drive, joint front corner of Lots 7 and 8, and running thence along the line of Lot 7 S.60-00 E. 133 ft., more or less, to a point in center of Gap Creek; thence up Gap Creek following the meanderings thereof in a northeasterly direction 100 ft., more or less, to iron pin in center of Creek at rear corner of Lot 9; thence with the line of Lot 9 N. 61-00 W. 141 ft., more or less, to iron pin in center of River Drive; thence with River Drive S. 23-30 W. 40 ft. to iron pin; thence continuing with River Drive S. 64-30 W. 59 ft., to beginning corner, and being known and designated as Lot 8, aforesaid plat, and the same property conveyed to J. T. Armstrong and Ralph E. Cantrell by C. Aaron Leapard, one-half interest in which was subsequently conveyed to R. H. McMackin by J. T. Armstrong.
Lot No. 2: BEGINNING at an iron pin in the center drive running thence S. 54-30 E. 151 ft. to the center of Gap Creek; thence up the creek as the line N. 45.15 E. 88 ft. to stake in creek; thence N. 50.00 W. 169 ft. to an iron pin in center of River Drive; thence with River Drive as the line S. 34.00 W. 99 ft. to a point in said Drive, the beginning corner, and being lot 9, said plat.
NOGETHER with all furniture, furnishings and fixtures located in the residence on the premises here-
As a part consideration, the grantees assume and agree to pay according to the terms thereof mortgage given by Herbert E. Rudd to First Federal Savings & Loan Assn. over Lot 9 described herein, dated July 9, 1955, in the original amount of \$3350.00, on which there is due a balance of \$1100.41 as of July 1, 1959.
