Hornor, IV, the receipt of which is hereby acknowledged have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William M. Hornor, Jr., as Trustee for Julia C. Hornor and William M. Hornor, IV, all that piece, parcel or lot of land lying, being and situate in Greenville County, South Carolina and in Glassy Mountain Township, on Branch Waters of Vaughn's Creek, adjoining lands of John Morgan, Mark Ballew, John Lockhart and G. C. Sudduth and described as follows:

> Beginning on a stone in J. W. Morgan old line and running South 32 East 440 feet to a stone in branch; thence with Sarah Blackwell line S. W. 410 feet to a stone 3X John Morgan corner; thence near North 546 feet with Anderson Morgan's new line to a poplar stump 3X; thence with Ballew line 846 feet to a stone; thence South 562 East 480 feet to oak stump near old road; thence South 40 2/3 West 480 to a stone near lod road; thence South 292 East 350 feet to a stone, the beginning corner, said tract containing Nineteen (19) acres, more or less.
