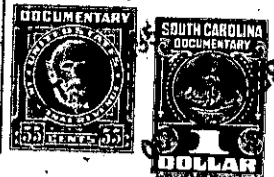

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lloyd W. Gilstrap and Levis L. Gilstrap, their heirs and assigns forever,

All that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, and having the following metes and bounds as shown on a plat of Overbrook Land Company, Tract Number 1, recorded in Plat Book J. at page 81:

BEGINNING at an iron pin at the joint rear corner of lots 20 and 21, and running thence with a line of property heretofore conveyed to Donald Gilstrap, N. 45-30 E. 100 feet more or less, to pin in rear line of Lot 24; thence with the rear line of Lots 24, 25, 26, 27 and 28, N. 24-27 W. 317 feet, more or less, to an iron pin at corner of lot conveyed to James H. Ferguson, Jr. by deed recorded in Deed Book 428 at page 361; thence with the line of said lot, S. 45-30 W. 212.8 feet to pin at joint rear corner of lots 15 and 16; thence with the rear line of lots 16, 17, 18, 19 and 20 S. 44-30 E. 300 feet to the point of beginning.

Being the same property conveyed to the grantor by Ellie Owen Taber by deed dated July 31, 1956, recorded in Deed Book 558 at page 219.
