

ALL those pieces, parcels or lots of land in Greenville County, State of South Carolina, situate on the southern side of Montclair Avenue (formerly Fairview Avenue), being shown as Lot No. 12 and the western one-half of Lot No. 13, of Block F, as shown on plat of Highland Terrace recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "K", at page 120-122, and being described as follows:

BEGINNING at a stake on the southern side of Montclair Avenue, 100.4 feet East from Waters Street, at corner of Lot No. 11; thence with line of said lot, S 21-00 W 151.3 feet to a stake on an alley; thence with the northern side of said alley, S 70-00 E, 43.5 feet to a stake; thence continuing with said alley, \$ 65-27 E, 25 feet to a stake, corner of property now or formerly belonging to Cora H. Dodson; thence N 23-13 E 150 feet to a stake on Montclair Avenue; thence with said Avenue N 70-47 W, 75 feet to the point of BEGINNING.
