until the full purchase price is paid, with interest on same from date at6\mathcal{2}per cent, per annum until paid to be computed and paid annually, and if unpaid to bear interest until paid at same rate as principal, and in case said sum or any part thereof be collected by an attorney, or through legal proceed-
ings of any kind. then in addition the sum ofdollars for attorney's fees, as is
shown by—saidnote of even date herewith. The purchaser agrees to pay all taxes while this contract is in force.
