Weaver, their heirs and assigns,

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 9 and a part of Lot No. 10, Block A on Plat of Mayfair Estates, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book S, pages 72-73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Mayfair Drive, joint front corner Lots 8 and 9, said iron pin being 335 feet in a southerly direction from the intersection of Lee Road and Mayfair Drive; and running thence along Mayfair Drive, S. 16-09 E. 75 feet to an iron pin; thence through Lot No. 10, N. 73-51 E. 167.15 feet to an iron pin; thence N. 10-18 W. 75.3 feet to an iron pin, joint rear corner Lots 8 and 9; thence S. 73-51 W. 174.8 feet to an iron pin, the point of beginning.
