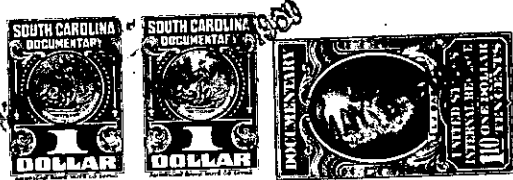

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot 38, of Indian Hills, plat of which is recorded in Plat Book QQ at Page 11, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Hunt's Bridge Road, at joint front corner of Lots Nos. 37 and 38, and running N. 82-35 E., 180 feet; thence N. 7-25 W., 100 feet; thence S. 82-35 W., 180 feet to an iron pin on Hunt's Bridge Road; thence with Hunt's Bridge Road, S. 7-25 E., 100 feet to the point of beginning.
