Know All Men by These Presents:

I, Bjarni Gudjonsson, That in consideration of the sum of Thirty Thousand (\$30,000.00)---in the State aforesaid, ___ DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Leslie and Shaw, Inc., a corporation, the following-described property:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the north side of East North Street, and having according to a survey made by Dalton & Neves, Engineers, February, 1956, the . following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of East North Street, which iron pin is 105.87 feet in a westerly direction from the northwest corner of the intersection of Thompson Street and East North Street, and is at the joint front corner of property heretofore conveyed to Featherknit Fabrics, Inc. (See Deed Book 546, Page 106, office of the R.M.C. for Greenville County), and running thence along the line of property of Featherknit Fabrics, Inc., N. 6-14 W. 196.3 feet to an iron pin on the south side of a 14-foot alley; thence along the south side of said 14-foot alley, S. 80-55 W. 37.5 feet to an iron pin on the south side of said 14-foot alley, at the joint rear corner of property herein conveyed and property now or formerly owned by J. Roy Jackson; thence along the line of property now or formerly of J. Roy Jackson, S. 6-44 E. 196.5 feet to an iron pin on the north side of East North Street, joint front corner of property herein conveyed and property now or formerly of J. Roy Jackson; thence along the north side of East North Street, N. 80-30 E. 35.87 feet to the beginning corner. Less that portion of the above-described property heretofore conveyed by grantor to the City of Greenville and the South Carolina State Highway Department. Together with all my right, title and interest in and to the 14-foot alley hereinabove referred to at the rear of the above-described property. Being the same property conveyed to grantor by James P.
