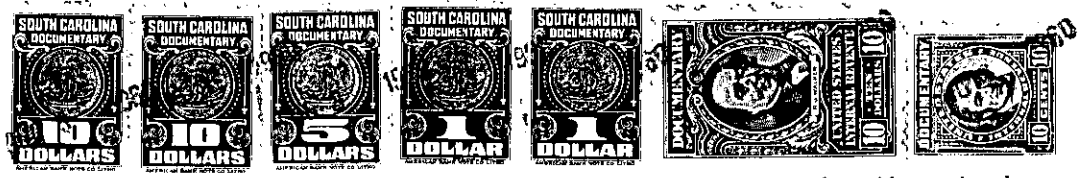

Wilson, his heirs and assigns:**

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #83, of a subdivision known as Thornwood Acres, Section 2, property of Williams Land Company, Inc., according to plat prepared by J. Mac Richardson, Engineer, dated April 1959, plat of which is recorded in the R.M.C. Office for Greenville County, in Plat Book MM, at Page 195, and according to said plat having the following metes and bounds:

BEGINNING at an iron pin on the southern side of Leafwood Drive, at the joint front corner of lots #83 and #82, and running thence along the line of lot #82, S. 18-58 E. 187.2 feet to an iron pin in the line of lot #73; running thence S. 73-01 W. 85.2 feet to an iron pin at the joint rear corner of lots #83 and #84; running thence along the line of lot #83, N. 18-58 W. 184.5 feet to an iron pin on the southern side of Leafwood Drive; running thence along the southern side of Leafwood Drive, N. 71-02 E. 85 feet to an iron pin, point of beginning.
