All that certain piece, parcel or lot of land lying and being on the northerly side of Heathwood Circle, near the Town of Taylors, S. C., being shown as Lot No. 68 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Heathwood Circle at a point 282.9 feet west of the northwesterly corner of the intersection of Heathwood Circle and Heathwood Drive, said pin being the joint front corner of Lots 67 and 68, and running thence with the joint line of said Lots N 20-43 E 167 feet to an iron pin; thence N 69-17 W 25 feet to an iron pin; thence N 70-16 W 202 feet to an iron pin, joint rear corner of Lots 68 and 69; thence along the joint line of said Lots S 21-09 E 230 feet to an iron pin on the northerly side of Heathwood Circle; thence along the northerly side of Heathwood Circle on a curve, the chord of which is S 76-20 E 78 feet to the point of beginning.
