VALENTINE, His heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in Chick Springs Township, County and State aforesaid, known and designated as Lot No. 39 on a Plat of "Rosedale", Revised May and June, 1960, prepared by C.
