Teasley, his heirs and assigns forever:

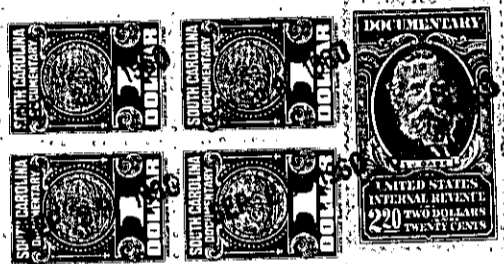
All that certain piece, parcel or lot of land, lying and being on the northeasterly side of Augusta Road, near the City of Greenville, S. C., being shown as Lot No. 1 on the plat of Magnolia Acres as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Augusta Road at a point 195 feet northwest of the northerly corner of the intersection of Augusta Road and Lord Fairfax Drive, said pin being the joint front corner of Lots 1 and 2, and running thence along the northeasterly side of Augusta Road N 53-41 W 80 feet to an iron pin; thence continuing with the northeasterly side of said Road N 56-11 W 118 feet to an iron pin; thence S 86-41 E 121.6 feet to an iron pin; thence N 34-22 E 122.3 feet to an iron pin, joint rear corner of Lots 1 and 7; thence with the line of Lot 7 S 56-0 E 92 feet to an iron pin, joint rear corner of Lots 1 and 2; thence with the line of Lot 2 S 33-30 W 187.9 feet to the point of beginning.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, successors, heirs and assigns forever.

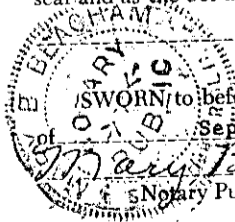
