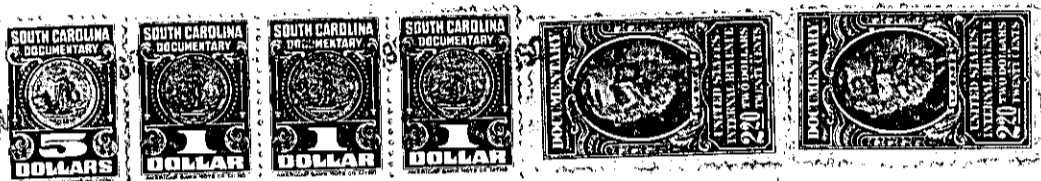
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. P. Porter and Wilma F. Porter, their heirs and assigns forever:

All of that tract of land, with the improvements thereon, situate near the Town of Mauldin, Austin Township, County of Greenville, State of South Carolina, being known as tract 9 containing 5.17 acres, according to plat made for Sanford L. Lindsey by C. O. Riddle, dated June, 1958 and revised on November 4, 1960 and being more fully described in accordance with said plat, to-wit:

Beginning at an iron pin on the northern side of Greenbriar Drive, said point being 827.1 feet from the intersection of Greenbriar and Log Shoals Road and running thence along tract 10, N 4-57 W, 592.2 feet to an iron pin; thence N 60 29 E, 153.5 feet to an iron pin; thence S 40-23 E, 680.7 feet to an iron pin on the edge of Greenbriar Drive; thence along Greenbriar Drive S 55-14 W, 109 feet to an iron pin; thence S 69-13 W, 100 feet to an iron pin; thence S 76-28 W, 130.4 feet to an iron pin; thence S 85-03 W, 215 feet to an iron pin, being the point of beginning. Being the same property conveyed the grantor of even date by Sanford L. Lindsey and to be recorded.
