Know All Men by These Presents:

That I, Harley Pat Roberts

in consideration of the sum of One Thousand (\$1,000.00) and assumption of mortgage in the State aforesaid, DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John Reed Mobley,

All that lot of land in the county of Greenville, state of South Carolina, designated as Lot No. 19, Block D, on plat of Brookforest, recorded in plat book BB page 41 of the RMC Office for Greenville County and having according to said plat and a recent survey made October 1956 by R. W. Dalton, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwest side of Woodmont Circle, the front joint corner of Lots 19 and 20; thence with the joint line of said lots S. 55-42 W. 197.3 feet to a point in the center of a branch; thence with the center of said branch as the line S. 41-27 E. 70.4 feet to a point corner of Lot No. 18; thence with the line of said lot N. 85-42 E. 187.9 feet to an iron pin on the southwest side of Woodmont Circle; thence with the southwest side of said Woodmont Circle N. 34-18 W. 70 feet to the beginning corner.

This is the same lot conveyed to grantor by Donald E. Baltz by deed recorded Nov. 16, 1956 in deed volume 565 page 336, and is conveyed subject to restrictions applicable to said subdivision recorded in book 476 page 153.

The grantee herein assumes and agrees to pay that certain mortgage held by C. Douglas Wilson & Co. in the original amount of \$14,700 recorded in the RMC Office for Greenville County in mtg. vol. 697 page 361, on which there is a balance due of \$ 13,335.34.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
