P. LAWS, his heirs and assigns, forever:

ALL that piece, parcel or lot of land being known and designated as lot 208 of subdivision known as Pine Forest as shown by a plat thereof, made by Madison H. Woodward, Engineer, said lot having the following metes and bounds:

BEGINNING at an iron pin on the southeast side of Pine Lake Circle at joint front corners of lots 209 and 208 and running S. 89-31 E. 278.2 feet to an iron pin, joint rear corners of lots 209 and 208; thence with the rear line of lot 208 S. 28-10 W. 66.9 feet to an iron pin, joint rear corners of lots 208 and 207; thence with the common line of lots 208 and 207 N. 89-31 W. 224.2 feet to an iron pin on Pine Lake Circle, joint front corners of lots 207 and 208; thence with the said Pine Lake Circle N. 20-10 W. 63.8 feet to an iron pin on Pine Lake Circle, the point of beginning.
