C. lying on the southern side of State Highway No. 415, and being a strip of land Fifty Feet (50) in width to be used and maintained by the said county as a public road, the description of which is as follows: The strip of land Twenty Five (25) in width along and paralel to the common property line of Robert E. Wade and all of the other grantors named above, the Wade strip having the following courses and distances: - Beginning on a point on the southern margin of the said Mighway No. 415, joint corner of Robert E.
