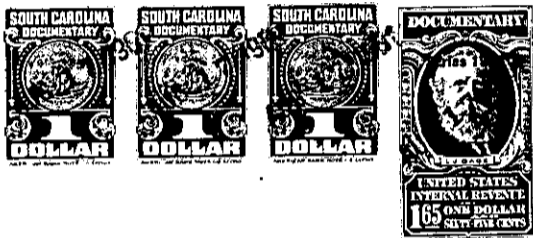

Cooper and Mable E. Cooper, their heirs and assigns forever,

All that lot of land in Greenville County, State of South Carolina, on the eastern side of Woodridge Circle; near the Town of Simpsonville, being shown as Lot No. 34 on a plat of Windsor Park recorded in Plat Book RR, at page 25, and described as follows:

BEGINNING at an iron pin on the eastern side of Woodridge Circle at the corner of Lot 35, and running thence with the line of said lot N. 29-18 E. 216.4 feet to an iron pin; thence S. 76-30 E. 80 feet to an iron pin; thence S. 21-0 E. 130 feet to an iron pin at the corner of Lot 33; thence S. 58-11 W. 194.4 feet to iron pin on Woodridge Circle; thence with the curve of the eastern side of Woodridge Circle, the chord of which is N. 50-52 W. 80 feet to the beginning.
