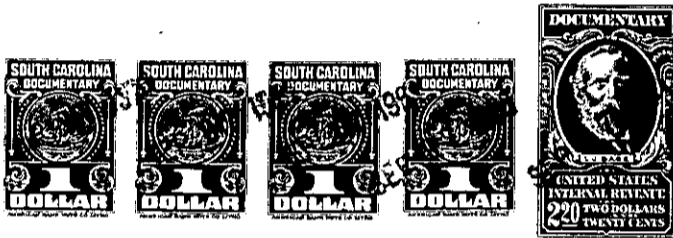

Wolfe and Martha S. Wolfe, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Paris Mountain Township, in the County and State aforesaid containing two (2) acres, more or less, according to a Plat of the O. B. and Helen Godfry Property made by C. C. Jones, Engineer, on the 14th day of September, 1955, and having the following metes and bounds, to-wit:
