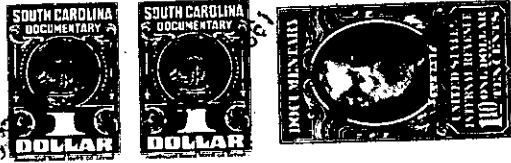
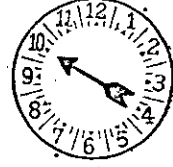

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. Glenn Abrams and Evelyn S. Abrams, their heirs and assigns forever:

ALL that piece, parce or lot of land in Greenville County, State of South Carolina, in Paris Township, being known and designated as Lot No. 80, as shown on a Plat of Section 2, Bellwood Estates, dated 1955, by Woodward Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 50, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on South Silver Lake Drive, joint front corners of Lots Nos. 79 and 80 and running thence along the line of said lots, S. 1-11 W. 207.1 feet to iron pin rear line of Lot 73 and 75; thence running with line of Lot 73, N. 43-34 W. 90 feet to iron pin rear corner of Lot 72; thence running with line of said lot, N. 5-10 W. 147.7 feet to iron pin on South Silver Lake Drive; thence running with said Drive, S. 85-54 E. 80 feet to iron pin at point of beginning.

NO residence shall be built on any lot costing less than Seven Thousand Five Hundred (\$7,500.00) Dollars; no residence shall be built on said lot nearer than twenty five (25) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.
