Teasley, his heirs and assigns forever:

All that certain piece, parcel or lot of land, lying and being on the southwesterly side of Fleetwood Drive, near the City of Greenville, S. C., being shown as Lot No. 60 on the plat of Magnolia Acres as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Fleetwood Drive, said pin being the joint front corner of Lots 60 and 61, and running thence with the joint line of said Lots S 48-32 W 152 feet to an iron pin; thence with the joint line of Lots 60 and 63 S 43-28 E 85 feet to an iron pin, joint rear corner of Lots 59 and 60; thence with the joint line of said Lots N 48-32 E 149 feet to an iron pin on the southwesterly side of Fleetwood Drive; thence with the southwesterly side of Fleetwood Drive N 41-28 W 85 feet to the point of beginning.
