COKER Grantee(s), and to the heirs and assigns of said Grantee(s), all that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 86 as shown on a plat prepared by C.C. Jones, dated October, 1947, entitled "Woodfields", recorded in the R.M.C. Office for Greenville County in Plat Book S at page 113, and having according to said plat the following metes and bounds:
