All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as lot #65 of a subdivision known as Wellington Green as shown on a plat thereof prepared by Piedmont Engineering Service, dated September 1961, to be recorded and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of lots #65 and #64, and running thence along the line of these lots N. 28-21 E. 172.5 feet to an iron pin; thence N. 60-13 W. 107.4 feet to an iron pin at the joint rear corner of lots #65 and #51; thence S. 25-57 W. 179.0 feet to an iron pin on the northern side of Melbourn Lane; running thence along the northern side of Melbourn Lane S. 63-37 E. 100 feet to an iron pin, point of beginning.

The above described lot is a portion of that property conveyed to me by Cora C. Howell by her Deed dated April 9, 1914, and recorded in the R.M.C. Office for Greenville County in Deed Vol. 60; at Page 130.

It is understood and agreed that this conveyance is subject to certain restrictions and protective covenants applicable to Wellington Green Subdivision, which have not been recorded on the date of this conveyance.
