All my right, title and interest in and to: All that piece, parcel and tract of land lying and being in Austin Township, Greenville County, South Carolina, containing 38.91 acres, more or less, being known as tract number 2 in a subdivision of lands of W. A. Pollard and Elisa Pollard as specifically set forth on a plat made by W. J. Riddle, Surveyor, recorded in Plat Book Q, Page 89, R. M. C. Office, Greenville County, South Carolina, and being the same tract of land conveyed to J. R. Richardson by I. S. Hamby by deed dated August 13, 1941, recorded in Deed Book 236, Page 141, R. M. C. Office, Greenville County, and by the said Richardson to Wilson Burton by deed dated January 8, 1947, recorded in Deed Book 305, Page 317, R. M. C. Office, Greenville County, South Carolina, and being likewise the same tract of land in which Wilson Burton conveyed a one-half interest to Inez Burton by deed dated January 13, 1947, recorded in Deed Book 305, Page 326, R. M. C. Office, Greenville County, South Carolina.

same or any part thereof.
