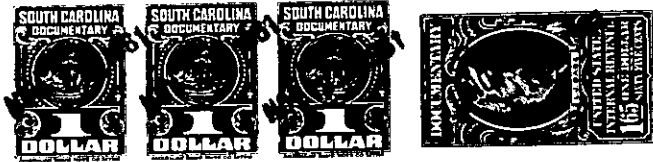

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 7, situate at the intersection of Sumler Drive and Cook Avenue, as shown on a plat of a subdivision for Sumler Hall, made by Pickell and Pickell dated May, 1950, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Cook Avenue, at the joint front corners of Lots Nos. 7 and 8, and running thence with Cook Avenue in a northerly direction 61 feet to an iron pin at the intersection of Sumler Drive; thence with Sumler Drive S. 89-30 W. 148 feet to an iron pin, joint rear corner of Lots 7 and 6; thence with the common line of the last two mentioned lines 61 feet to an iron pin; thence N 89-30 E. 148 feet to an iron pin on Cook Avenue, the point of beginning.
