BALTZ:

All that piece, parcel or lot of land situate, lying and being on the Southern side of Vicki Circle in the County of Greenville, State of South Carolina, being known and designated as Lot No. 37 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southern side of Vicki Circle at the joint front corner with Lots 37 and 38 and running thence with the southern side of Vicki Circle S. 85-29 E. 100 feet to an iron pin, the joint front corner with Lot 36, thence along the line of Lot 36 S. 4-31 W. 203.5 feet to an iron pin, thence turning and running N. 77-58 W. 100.86 feet to an iron pin, the joint rear corner with Lot 38, thence the line of Lot 38 N. 4-31 E. 190 feet to an iron pin, the point of beginning.
