the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Eugene Rackley, his heirs and assigns:

ALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as Lot #8, of a subdivision known as Sharon Park, plat of which was prepared by C. C. Jones and Associates, Engineers, dated April 1955, and a revised plat dated May 15, 1956, and is recorded in the R.M.C. Office for Greenville County in Plat Book EE, at Page 130, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Sharon Drive, the joint front corner of lots #8 and #9 and running thence along the line of these lots, S. 14-40 E. 153.6 feet to an iron pin in the line of lot #11; running thence S. 77-17 W. 45 feet to an iron pin at the joint corner of lots #8, #11, #5 and #6; running thence N. 45-25 W. 88.5 feet to an iron pin; thence N. 14-40 W. 77 feet to an iron pin on the southern side of Sharon Drive; running thence along the southern side of Sharon Drive, N. 75-20 E. 97 feet to an iron pin, point of beginning.
