J. A. Barry, his heirs and assigns, forever,

ALL that certain piece, parcel, or lot of land in Paris Mountain Township, Greenville County, South Carolina, on the western side of Paris View Drive (now known as Montis Drive), and known and designated as Lots 42 and 43 on a plat entitled "Map of Paris View" prepared by Dalton & Neves, Engineers, in March, 1949, and recorded in Plat Book "W", at page 32. According to this plat, these lots have the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of Lots 41 and 42, which iron pin is S. 19-06 W. 60 feet from the southwestern corner of the intersection of Montis Drive and Gay Street, and running thence along the western edge of Montis Drive S. 19-06 W. 120 feet to an iron pin at the joint front corner of Lots 43 and 44; thence along the line of Lot 44 N. 70-54 W. 175.7 feet to an iron pin; thence N. 19-13 E. 120 feet to an iron pin at the joint rear corner of Lots 41 and 42; thence along the line of Lot 41 S. 70-54 E. 175.2 feet to the beginning.
