
Deed for South Carolina

Grantee(s), and to the heirs and assigns of said Grantee(s), All that lot of land in the county of Greenville, State of South Carolina, on the north side of Westbrook Drive, formerly Harmon Drive, known and designated as Lot No. 15 on plat of J. E. Harmon recorded in plat book L page 153 of the Office of RMC for Greenville County, S. C., said lot having a frontage of 75 feet on the north side of Westbrook Drive, (formerly Harmon Drive), a depth of 205.9 feet on the northwest side, a depth of 205.85 feet on the southeast side and a rear width of 75 feet.
