to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Rudalph Lock, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situated on Highway No. 29, just below the town of Piedmont, South Carolina, being known and designated as Lots Nos. 77 and 78 of a subdivision known as Monticello Estates, as shown by a Plat thereof, by Woodward Engineering Company, dated March 1956, recorded in the R.M. C. Office for Greenville County, in Plat Book EE, at Page 169, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on North Monticello Road at joint front corners of Lots 76 and 77 and running thence along the line of said lots, N. 19-40 E. 200 feet to iron pin; thence running, S. 70-20 E. 83.23 feet to iron pin at rear corner of Lot 78; thence running, S. 70-20 E. 83.23 feet to iron pin at rear corner of Lot 79; thence running with line of Lot 79, S. 19-40 W. 200 feet to iron pin on North Monticello Road; thence running with said Road, N. 70-20 W. 83.23 feet to iron pin at front corner of Lot 77; thence running N. 70-20 W. 83.23 feet to iron pin at point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on any lot; no residence shall be erected on any lot nearer than forty (40) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
