in consideration of the sum of Five Hundred and no/100 (\$500.00) in the State aforesaid, -----DOLLARS,

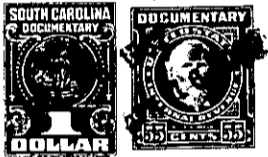

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 122 on plat of Western Hills, recorded in the R.M.C, Office for Greenville County in Plat Book QQ, Pages 98-9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Alice Farr Drive at the joint front corner of lots 121 and 122 and running thence with the common line of said lots N. 66-10 E. 279 feet, more or less, to an iron pin; thence N. 39-43 W. 140 feet to an iron pin; thence S. 58-05 W. 252 feet, more or less, to an iron pin on the southeasterly side of Alice Farr Drive; thence with said drive S. 26-01 E. 72 feet to an iron pin; thence continuing with said drive S. 35-07 E. 27.9 feet to the point of beginning.
