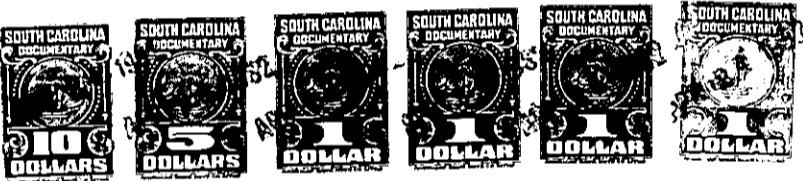
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto C. Harold Jones and Joyce A. P. Jones, their heirs and assigns, forever:

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 41 on Plat of Western Hills recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book QQ at Pages 98-9, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Tucson Drive at the joint corner of Lots Nos. 40 and 41 as shown on said Plat, and running thence along the line of Lot No. 40, N. 33-22 W. 165.7 feet to an iron pin; thence S. 42-38 W. 204 feet to an iron pin on the northeasterly side of Alice Farr Drive; thence with said Drive, S. 42-06 E. 70 feet to an iron pin; thence continuing with said Drive, S. 37-30 E. 25 feet to an iron pin; thence around the curve of the intersection of Alice Farr Drive and Tucson Drive, the chord of which is S. 81-04 E. 36.2 feet to an iron pin on the northeasterly side of Tucson Drive; thence with said Drive, N. 55-15 E. 158.8 feet to the point of beginning.

This conveyance is subject to the recorded restrictions applicable to Western Hills, and to the easements and rights-of-way, if any; and the set-back line as shown on said Plat.
