Greenville aforesaid, by virtue of the aforesaid decree, gift and pursuant to Decree of Court

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto

the said J. H. Cooper, John M. Flynn and J. W. Matthews as Trustees for the Edwards Road Baptist Church, their successors and assigns:

All that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, containing approximately 5 acres, being shown as tract "A" on plat of Botany Woods, Sector 1, recorded in Plat Book QQ at page 78 and having according to a plat made by Piedmont Engineering Service in October 1961, recorded in Plat Book AAA, page 57, and having according to the last mentioned plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Edwards Road, at the corner of 1ot 104 and running thence S 26-20 E 333.8 feet to pin; thence S 44-15 E 160 feet to pin; thence S.76-14 E 152 feet to pin; thence N 70-02 E 222.2 feet to pin; thence N 26-19 W 383.2 feet to pin at corner of lots 106 and 105; thence N 38-55 W 305.5 feet to pin on Southeastern side of Edwards Road; thence with the Southeastern side of Edwards Road the following courses and distances: S 45-06 W 130 feet; S 48-59 W 100 feet; S 60-09 W 100 feet to the beginning corner.

Said premises being the five acres which was reserved by the owners when the remainder of the tract was conveyed to James L. Love and W. W. Wilkins, Trustees.
