KNOW ALL MEN BY THESE PRESENTS, that We, James W. Crisp and Myrtle B. Crisp,

in consideration of sum of One and 00/100(\$1.00)-----and assumption of real estate Dollars,  
mortgage balance hereinbelow described,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Mary Emma Crisp, her heirs and assigns, forever:

All that lot of land with the buildings and improvements thereon, situate on the North West corner of the intersection of Forestdale Drive and Red Cherry Lane, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 16 on plat of Forestdale Heights, made by R.K. Campbell, December 1956, and revised November 1958, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book KK, Page 199, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING AT AN IRON PIN ON THE NORTH side of Forestdale Drive at joint front corner of Lots 15 and 16 and runs thence with the line of Lot 15, N. 4-31 E., 200 feet to an iron pin; thence S. 85-29 E. 80 feet to an iron pin on the West side of Red Cherry Lane; thence along Red Cherry Lane, S. 4-31 W. 185 feet to an iron pin; thence with the curve of Red Cherry Lane and Forestdale Drive(the chord being S. 49-31 W., 21.2 feet) to an iron pin on the North side of Forestdale Drive; thence along Forestdale Drive, N. 85-29 W., 65 feet to the beginning corner.

This is the same deed and property which was conveyed to the grantors herein by deed of L.A. Moseley, Inc., and recorded in the RMC Office for Greenville County, in Book 646, at page 85.

The grantee herein as a part of the consideration for this deed assumes the balance now due on a mortgage held by the General Mortgage Co., Greenville, S.C. involving this real estate, on which there is a balance of \$14,493.97.
