All that tract or lot of land in Greenville County, State of South Carolina, on the southeast side of Edwards Road, containing 9.86 acres, more or less, and having, according to a survey and plat made by C. O. Riddle, Surveyor, November, 1959, the following metes and bounds, to-wit:
