in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Harry R. Stephenson, Jr. and William K. Stephenson, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on Paris Mountain, near the City of Greenville, S. C., being bounded on three sides by a curve of Altamont Road, and being shown on a plat showing the relocation of a portion of Altamont Road as the same affects the property of Ann H. Eastland and the property of Harry R. Stephenson, Jr. and William K. Stephenson, which plat is recorded in the RMC Office for Greenville County in Plat Book CCC, page 23, and having according to said plat the following metes and bounds, to-wit:

BEGINNING AT an iron pin on the southeasterly side of Altamont Road and running thence along a new line through the property of Ann H. Eastland, which line is the easterly edge of the proposed right-of-way for the relocation of Altamont Road, S 10-12 E 94 feet to an iron pin; thence continuing with the easterly edge of the proposed new right-of-way S 16-26 E 42.9 feet to a point in the northwesterly side of the presently existing Altamont Road; thence with Altamont Road the following courses and distances: S 39-35 W 122 feet to an iron pin at the edge of a curve in Altamont Road; thence around said curve on a chord S 54 E 51 feet to an iron pin; thence N 24-48 E 217.2 feet to the point of beginning.

This is a portion of the property conveyed by the grantees herein to the grantor herein by deed dated July 7, 1961 and recorded in the RMC Office for Greenville County in Deed Book 677, page 265.
