All that piece, parcel or lot of land situate, lying and being in Butler Township, Greenville County, State of South Carolina, containing 2.9 acres, more or less, and being known and designated as Lot No. 5 of Rolling Green Real Estate Co., as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "XX", at Page 33 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Rolling Green Circle at the joint front corner of Lots Nos. 4 and 5 and running thence along the joint line of said lots, N. 30-38 E. 437 feet to an iron pin; thence S. 32-45 E. 204.5 feet to an iron pin; thence S. 86-15 E. 60 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence along the line of Lot No. 6 S. 13 W. 442 feet to an iron pin on the northern side of Rolling Green Circle; thence along Rolling Green Circle N. 52 W. 370 feet to the beginning corner.
