the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

C. A. Tollison his Heirs and Assigns forever:

All that piece, parcel or tract of land lying, being and situate in the County and State aforesaid, containing sixty-nine (69) acres, more or less, with the following metes and bounds, to-wit: Beginning at a stone on the North Bank of Reedy River, joint corner with lands of Henry F. Weathers, and running thence with the joint line of the Westhers land N. 6-1/2 E. 1,866.48 feet to a stone; thence N. 73 W. 82.5 feet to an iron pin, joint corner with lands of James W. Moore and Henry F. Weathers; thence with the joint line of the Moore property N. 20-45 W. 686.4 feet to an iron pin on line of land of C. J. Jones, Jr., formerly Eskew; thence with the joint line of the Jones land S. 70-00 W. 332 feet to an iron pin, joint corner with other lands of the Grantor; thence with joint line of other lands of the Grantor in a southerly direction 400 feet to an iron pin; thence in a Southwesterly direction along joint line of other land of the Grantor approximately lol4 feet to an iron pin on line of land of the Grantee; thence with the joint line of land of the Grantee S. 2-5/6 W. 1910 feet to a rock on the bank of Reedy River; thence with Reedy River, down said River, as the line to the point of beginning, and bounded by lands of Weathers, Moore, Jones, other lands of the Grantor and other lands of the Grantee.

The Grantor herein reserves the right to use the well on the premises herein conveyed for himself his heirs and assigns forever.

The right of egress and ingress over a farm road on the premises of the Grantor is hereby granted to the Grantee his Heirs and Assigns forever.

This conveyance is made subject to any existing timber contract over the conveyed premises.

The within conveyed premises being a portion of two tracts of land which were conveyed to the Grantor by deedoof Bessie Robertson, et al and by deed of Walter L. Thompson of record in the R. M. C. Office for Greenville County, S. C., in Deed Books 488, Page 447 and Deed Book 518, Page 394, respectively.
