## Know All Men by These Presents:

Miller, in the State aforesaid, in consideration of the sum of Twelve Hundred Fifty and no/100 (\$1,250.00) and assumption of mortgage hereinbelow described, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Francis O. Burnett, Jr. and Phyllis E. Burnett

ALL that piece, parcel or lot of land near the City of Greenville, County of Greenville, State of South Carolina on the northwestern side of Deerfield Road being known and designated as Lot No. 290 according to a plat recorded in the R.M.C. Office for Greenville County in Plat Book Z, page 121, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Deerfield Road, said iron pin being the joint front corner of Lots Nos. 290 and 291, being 68 feet N. 16-56 E. from the northwest intersection of Deerfield Road and Foxhall Road and running thence N. 56-29 W. 213.1 feet to an iron pin; thence N. 51-37 E. 100 feet to an iron pin; thence S. 49-52 E. 175 feet to an iron pin on the north-western side of Deerfield Road, thence with Deerfield Road, S. 27-10 W. 74.7 feet to an iron pin point of beginning.

As a part of the consideration herein, the grantees do expressly agree to assume and pay that certain mortgage heretofore given by Owen M.
