Know all Men by these presents, That A. M. Stone, Eugene E. Stone, Jr., Harriet M. Stone and Ann S. Cleveland, as Executors and Executrices of the estate of Eugene Earle Stone, deceased, and Eugene E. Stone, III, Eugene E. Stone, Jr., Ward S. Stone, Thomas W. Miller, and Eugene E. Stone, of Florence, S. C., as Trustees and Executors of the Estate of T. C. Stone, deceased,

in the State aforesaid, in consideration of the sum of

Five Thousand and No/100-----(\$ 5,000.00)----- Dollars

to us paid by Lewis L. Alexander, Jr.

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lewis L. Alexander, Jr., his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 37 of a subdivision known as Stone Lake Heights, Section III, as shown on a plat thereof prepared by Piedmont Engineering Service, October 1, 1958, revised May 26, 1961, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at page 96, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the edge of a turnaround at the end of Stone Lake Court, the joint front corner of Lots Nos. 36 and 37, and running thence along the joint line of said lots, S. 65-57 E. 207.6 feet to an iron pin on the subdivision boundary line; thence along the subdivision boundary line, S. 4-58 E. 60.0 feet to an iron pin; thence continuing along the subdivision boundary line, S. 73-25 W. 210.0 feet to an iron pin, joint rear corner of Lots Nos. 37 and 38; thence along the joint line of said lots, N. 12-10 W. 185.0 feet to an iron pin on the edge of said turnaround; thence following the curvature of said turnaround, the chord being N. 79-07 E. 30.0 feet, to an iron pin; thence continuing with the curvature of said turnaround, the chord being N. 42-42 E. 25.0 feet, to the beginning corner.

This conveyance is subject to recorded easements and rights-of-way for the installation and maintenance of public utilities and to drainage easements as shown on the recorded plat; and there is also imposed upon the above described lot restrictions and protective covenants identical to those recorded in the R. M. C. Office for Greenville County in Deed Vol. 632, at page 41.
