

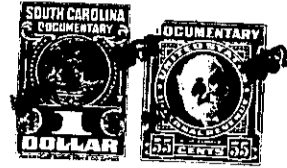

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Gordon O. Jones and Ethel L. Jones, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 248, as shown on a plat of Section 2, Caroline Court, dated November 1953 by Dalton & Neves Engineers, recorded in the R.
