- That Gantt Water and Sewer District agrees to maintain said sewer lines in accordance with standard sewerage disposal practices and in accordance with the rules and regulations now promulgated or to be promulgated by Greater Greenville Sewer District Commission.
- 4. There are no electors in the area involved and Chanticleer, Inc. is the sole owner of the land in such area.
