Know all Men by these presents, That I, W. N. Leslie, of Greenville County,

in the State aforesaid, in consideration of the sum of Ten and No/100 (\$10.00), love and affection - - - - - Dollars

to me paid by Angeline D. Leslie

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Angeline D. Leslie, her heirs and assigns forever: All my right, title and interest, the same being an undivided one-half interest, in and to the following described property:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the North side of East Hillcrest Drive and being known and designated as the west 50 feet of Lot 19 and the east 50 feet of Lot 20 of Section E, as shown on plat recorded in Plat Book "G", Page 208, and having the following metes and bounds, to-wit:

BEGINNING at a point in line of Lot 20 on the north side of East Hillcrest Drive, which is Poole's corner; thence along East Hillcrest Drive, S. 66-30 E. 100 feet to a point in line of Lot 19, which is Bloom's corner; thence with Bloom's lot, N. 23-30 E. 190 feet; thence with rear line of Lots 19 and 20, N. 66-30 W. 100 feet to Poole's corner; thence with his line, S. 23-30 E. 190 feet to beginning; being the same property conveyed to W. N. Leslie and Angeline D. Leslie by Dorothy Hindman Davenport, et al. by deed dated July 1, 1949 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 386, at Page 38.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, beginning at a pin 25 feet west of the corner of Lot 17, of the subdivision of lots hereinafter named, and on the north side of East Hillcrest Drive; thence N. 23-30 E. 190 feet to a pin on the rear line of Lot 13; thence with rear line of Lots 13 and 12, N. 66-30 W. 75 feet to a pin on rear line of Lots 12 and 19, and 25 feet west of the corner of Lot 18; thence S. 23-30 W. 190 feet to Hillcrest Drive; thence with north side of Hillcrest Drive, S. 66-30 E. 75 feet to the beginning corner; being the same property conveyed to W. N. Leslie and Angeline Leslie by H. K. Townes, et al. by deed dated February 1, 1949 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 372, at Page 226.
