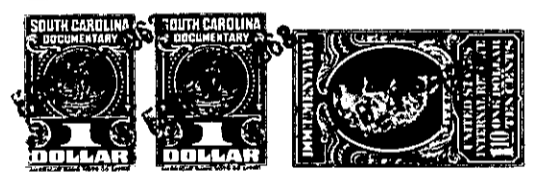
KNOW ALL MEN BY THESE PRESENTS, that I, Hugh B. Cureton,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto C. J. Moody, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and being more particularly located in the Oak Hill Subdivision, Section B, near Greenville, South Carolina and being known and designated as lot number 12 on Oak Hill Drive according to a plat of the same prepared by J. C. Hill; said plat being recorded in Plat Book MM at page 81 in the R. M. C. Office for Greenville County; said lot of land being described by metes and bounds as follows:

BEGINNING at an iron pin at the joint front corners of lots numbers 11 and 12, which front on Oak Hill Drive, thence proceeding with said Drive S. 41-21 W. 75 feet to an iron pin at the joint front corners of lots numbers 12 and 13; thence turning and proceeding S. 47-16 E. 175.2 feet to an iron pin at the joint rear corner of lots numbers 12 and 13; thence turning and proceeding N. 68-40 E. 57 feet to an iron pin; thence continuing N. 58-18 E. 16.4 feet to an iron pin at the joint rear corner of lots numbers 11 and 12; thence turning and proceeding S. 48-39 E. 150.6 feet to the point of beginning.
