the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto WILLIAM E. MATHEWS, his heirs and assigns,

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Fifty-Seven (57) of Section One of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962 and recorded in the RMC Office for Greenville County in Plat Book YY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the western side of Michaux Drive at the joint front corner of Lots 40 and 57 and running thence with the western side of Michaux Drive N. 3 - 57 W. 60 feet to an iron pin; thence still with the western side of Michaux Drive N. 0 - 55 W. 71.5 feet to an iron pin at the joint front corner of Lots 57 and 58; thence with the line of 58 S. 87 - 48 W. 190.4 feet to an iron pin on the line of Lot 56; thence with the line of Lot 56 S. 6 - 57 W. 36 feet to a pin at the joint rear corner of Lots 41, 42, 56 and 57; thence with the line of Lot 41 S. 43 - 39 E. 146.6 feet to an iron pin at the joint corner of Lots 40, 41 and 57; thence with the line of Lot 40 N. 79 - 48 E. 100.1 feet to the beginning corner.
